Senator Conrad Appel, sponsor of SB 597 and Chairman of the Senate Education Committee, certainly didn't waste any time getting Governor Jindal's Education Reform bill approved. Think he was incentivized???

Gov. Bobby Jindal donated \$2,500 to Sen. Appel in 2011.
